Date: Saturday, October 10, 2020

Time: 10:00 am - 4:00 pm (No early take downs)

Set up time: Saturday, October 10, 2020 at:8:00 am and vendor must be ready by 9:45 am to sell.

Be sure the submit your completed vendor application as soon as possible to guarantee your space at this year's event. Space is limited: vendors will be given priority on first come first serve basis.

Admission to this event is free.

FEES: The cost for this space is \$35.00 if you need a table and \$25.0.00 if you do not need a table.

1. You can mail your application and payment together to Michelle Behal, 7076 Maplewood Rd. Parma Heights, Ohio 44130 no later than October 6, 2020. No applications will be accepted after October 6, 2020.
2. You are not confirmed until you have paid for your space, regardless if you have submitted an application. Once your space and application has been received, you will receive a confirmation email or mail to confirm your space.

TABLES: Tables are limited. They will be given on a first come first serve basis. Vendors who pay for a table space will receive an 8 foot table. Table covers will not be provided. All vendors must provide their own if they choose to use one.

ELECTRICITY: Electricity is available. If you require electricity, you must bring your own extension cord and you must state that you need electric. If you do not state that you need electric, we won't be able to plan your space.

FOOD: You are welcome to bring your own food during the show. There will be food available for purchase during the show. You may also leave and buy your lunch at any of the local restaurants.

INSURANCE: If you are not covered by a business insurance policy, it is strongly recommended that you purchase some sort of liability insurance to cover you, your wares and your equipment. Participants agrees to assume all risks and releases the Parma Area Fine Arts Council, The City of Parma, The Donna Smallwood Activity Center, the employees, staff, volunteers from any and all liabilities from any and all claims for injuries, damage or loss, including, but not limited to, loss or damage of vendors' property in the car, custody or control of the vendor. In addition, The Parma Area Fine Arts Council, The City of Parma, The Donna Smallwood Activity Center, the employees, staff, volunteers are not responsible for any broken or lost or stolen items as a result from leaving your booth unattended.
